What is safe programming?

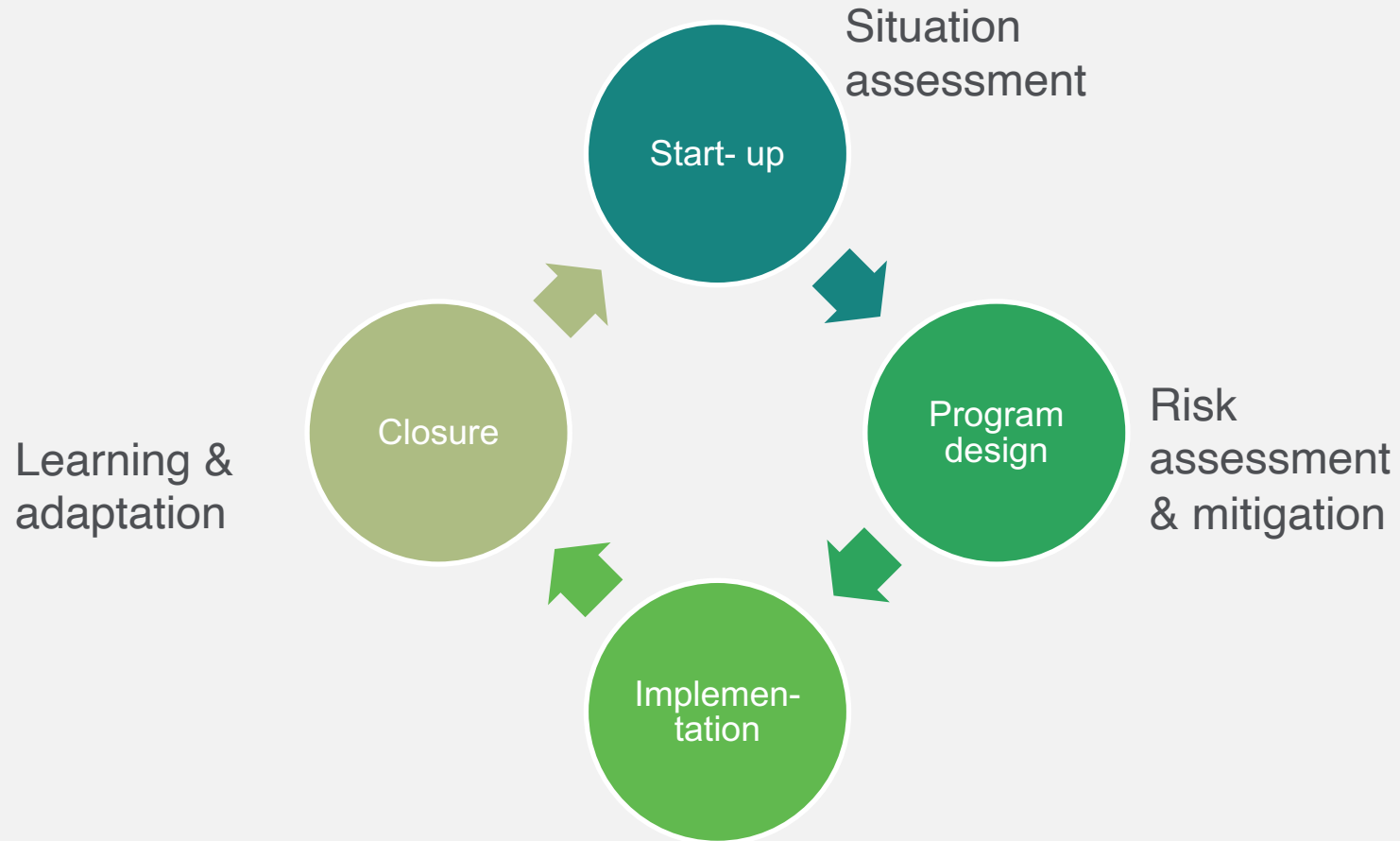
- Safe programming is ensuring that members of the community where you work are safeguarded from any intentional or unintentional harm that may arise from your programmes
- Safe programming is about organisational integrity and accountability
- It is ensuring the safety of EVERYONE who comes into contact with your program
- Safe programming is NOT about mitigating every risk. Some risks are beyond our control- identify, assess and continuously monitor
- Safe programming involves having conversations with community members, families and programme participants on what can be done to keep them safe

What do you need to put in place?

So what does this mean in practical terms?

1. Appoint a focal safeguarding person
2. All staff (including support, visitors) should receive safeguarding training.
3. Conduct a mapping of vetted services around you and share this with staff (including programme participants)
4. Develop a plan of action
5. Ensure reported cases are handled only by those trained to do so
6. Have a clear process on how to support a survivor or victim
7. Have a clear disciplinary process
8. Integrate safeguarding into your programme design & delivery

How to integrate safe programming



Guiding principles

- ✓ **Do no harm.** The best interest of your programme participants should always be at the heart of every decision
- ✓ **Participation.** Community members including children should be asked what makes them feel safe and unsafe
- ✓ **Training.** Everyone working in your organization or program should be trained and feel confident in designing and implementing safe programs
- ✓ **Adaptation.** Learning should be taken seriously and planned throughout a program cycle to enable adjustments where necessary
- ✓ **Sustainability.** At every stage, efforts to promote safe programming should actively involve the wider community

Conclusion

Key points to remember

1. Safe programming is about organisational integrity and accountability
2. It is an iterative process of learning and adaptation
3. You can not anticipate or mitigate every risk- but you CAN identify, monitor and build these risks into your program at every stage
4. Safe programming efforts should always involve the entire community to create a long-term safe environment
5. The best interest of your programme participants should always be at the heart of every decision
